documents will be available for sale from the P.W. Department of this Municipality on payment of the cost of tender papers as mentioned below. However the Municipality preserves the right of rejecting any application without showing

any cause thereof. Sealed tenders addressed to the Chairperson only. The left hand corner of the envelop containing the tender should be marked with the name for which it is tendered. The authority does not bind itself to accept the lowest tender and reserves the right to accept or reject any or all tenders without

assigning any reason whatsoever. All other terms and conditions may be seen from the detailed tender documents.

Cess will be charged as per Govt. Rule.


