The Chairman, Uttarpara-Kotrung Municipality, Dist. Hooghly, West Bengal invites sealed tenders in two bid system from bonafide, reliable and resourceful contractors having experience in similar nature of work(s) as mentioned below.

Application, in duplicate, enclosing single photo copy of necessary credentials, **Valid Pan issued by the I.T. Deptt., Govt. of India, Valid 15 digit Goods and Services Tax payer identification Number (GSTIN) under GST Act, 2017 and Trade License etc.** "Tax invoice(s) needs to be issued by the supplier for raising claim under the contract showing separately the tax charged in accordance with the provisions of GST Act, 2017". As instructed by Govt. of West Bengal vide Memo No.4374/F(Y) Dt. 13-07-2017. For obtaining permission of issuing tender documents will have to be submitted to the Chairman of this Municipality with due production of original certificates - Credentials/ documents relating to successful completion of similar nature of **single work within last 3(three) years** valuing at **1/3rd** of the amount of tender under any Government / Semi Government Departments. Complete tender documents will be available for sale from the W.W. Department of this Municipality on payment of the cost of tender papers as mentioned below. However the Municipality preserves the right of rejecting any application without showing any cause thereof. Sealed tenders addressed to the Chairman only. The left hand corner of the envelop containing the tender should be marked with the name for which it is tendered.

The authority does not bind itself to accept the lowest tender and reserves the right to accept or reject any or all tenders without assigning any reason whatsoever.

All other terms and conditions may be seen from the detailed tender documents.

Cess will be charged as per Govt. Rule.

All the Tender documents should be filled up properly by the Contractor, failing which the Tender will be considered as Informal.

Earnest Money should be deposited through Bank Draft / Pay Order in favour of "Uttarpara-Kotrung Municipality".

Payment will be made after all the statutory deductions as per prevailing Govt.

GST will be paid separately as applicable & admissible.

During the tender evaluation process, the "BID A" will be opened first. Those tenderer who have qualified the essential & other requirements will be identified and only their "BID B" i.e. financial bid will be opened. The "BID B" of those tenderer failing to meet the technical & other requirements of participating in the tender will not be opened and will be rejected.
