

<u>Sl No.</u>	<u>Description of Item/Work(s)</u>
1.	2 wheeled open top Trolley size: 10'-0" x 6'-0" x 2'-0" Chassis fabricated from 4" x 2" M. S. channel and 2" x 2" x ¼" & 1 ½" x 1 ½" x ¼" M. S. angle with "A" type drawbar and eyehook. Platform covered with 5 mm thick M. S. sheet. Side frame fabricated from 40 x 40 x 5mm M. S. angle and covered with 2.5 mm M. S. sheet. Three side of the body are drop down type and one side (Front) is fixed. The trolley fitted with one no. 2 ½" Sqr. M. S. axle with taper roller bearing & heavy duty Hubs, 2 nos. 2 ½" x 3/8" x 12 leaves leaf spring fitted with the trolley with U clamp and jhulan patti. The trolley fitted with 2 nos. 750-16 Wheel (CEAT/MRF/JK) with Churi rim & tube. Inside the body painted with black anti-corrosive paint and outside with synthetic enamel paint over red oxide primer and writing the name of the Municipality.
2.	1.5 Ton capacity 2 wheeled all covered Stainless steel body garbage Trolley, size 6'-0"x 4'-0"x 1'-6"+1'-0". Chassis made from 100 mm x 50 mm x 6 mm M. S. channel, 50 mm x 50 mm x 6 mm M.S. angle with "A" type drawbar & eye hook & back hook. Parking stand made from 50 mm x 50 mm x 6 mm M.S. angle sides & top structure made from 32 mm. square Stainless Steel hollow tubes. Both sides are provided with 1 no. loading doors & 1 no unloading door. Floor covered with 3 mm Stainless Steel Sheet and side & top with 2 mm. The Trolley fitted with 2 Nos. 750- 16 tyre & tube and heave duty 5 hole Rim, 2 nos. 65 mm x 10 mm x 8 leaves laminated leaf spring with U clamp & Jhullan Patti, one no. 50 mm Sqr. M. S. axle with heavy duty Hubs & Tapper roller Bearing etc. The Iron portion of the Trolley painted with black anti corrosive paint over red oxide primer and Stainless Steel portion with mirror finish polish and writing the name of the Municipality.

Application, in duplicate, enclosing single photo copy of Valid Pan issued by the I.T.
