04. Criteria to participate in the Tender : -

The intending tenderer must have minimum one year experience in operation & maintenances of such vehicles as indicated above.

Tenderer having valid GSTIN number, PAN, Trade License(Mechanical Contractor), Registration of W.B. Contract Labour (Regulation & Abolition) Act and possesses valid ESIC & EPF Registration Certificates, I.T. Return (for last quarter of 2019-20), & Financial Statement for the year 2019-20 (P/L & Balance Sheet) are entitled to participate in the tender process.

- 05. Machine should be deployed at various sites within the municipal area or outside the municipal area as per necessity of the municipality.
- 06. The whole work shall be carried out in accordance with the **operation & maintenance scheduled** (**details of which is enclosed herewith**) and the same be operated as per direction given by the official, In–charge of Sanitary Inspector of the respective department of this municipality.
- 07. **Log Book** to be provided for maintaining and daily recording DOL, Work done details in different location of work site.

- 08. The successful tenderer shall have to perform necessary routine check up and maintenance of the machines in due courses. The routine **verification of the overall mechanical condition** of vehicles (i.e cesspool emptier of 3200Lt) be done after each and every three months by the **Engineer** of Conservancy Department. On the basis of the report the vehicles be maintained by the agency accordingly.
