Contract Labour (Regulation & Abolition) Act and possesses valid ESIC & EPF Registration Certificates, I.T. Return (for last quarter of 2019-20), & Financial Statement for the year 2019-20 (P/L & Balance Sheet), credential of against execution of same nature of work are entitled to participate in the tender process.

- 05. Machine should be deployed at various sites within the municipal area or outside the municipal area as per necessity of the municipality.
- 06. The whole work shall be carried out as per direction given by the official, In-charge of Sanitary Inspector of the respective department of this municipality.
