Other Important Terms & Conditions :-

- A) The detailed N.I.T, documents and other relevant particulars may be seen by the intending tenderer during office hours within the date mentioned above in the Municipal office.
- B) The materials related to the work are to be supplied in accordance with the specification of the B.O.Q by the tenderer. Deduction @ 10% (2%+8%)of the Gross amount of the bill will be made as security deduction against work done value and the same will be returned to the agency after 3 (three) years from the date of actual work done subject to fulfillment of the conditions applied. However the security deposit of the contractor held with the Municipality under the provision of Clause 1 of Form No. 2911/2911(ii) should be treated amended as per memo no. 177-CRC/2M-57/2008 dt. 12/07/12 of Public Works Department as follows:
