Other Important Terms & Conditions :-

- A) The detailed N.I.T, documents and other relevant particulars may be seen by the intending tenderer during office hours within the date mentioned above in the Municipal office.
- B) The materials related to the work are to be supplied in accordance with the specification of the B.O.Q by the tenderer. Deduction @ 10% (2%+8%)of the Gross amount of the bill will be made as security deduction against work done value and the same will be returned to the agency after 3 (three) years from the date of actual work done subject to fulfillment of the conditions applied.
