#### **Other Important Terms & Conditions:-**

A) The materials related to the supply work are to be supplied in accordance with the specification by the tenderer. Deduction @ (2%+8%=10%) of the Gross amount of the bill will be made as **security deduction** & **2% earnest money** will be adjusted to the security deposit of the 10% gross deduction against work done value and the security

deposit will be returned to the agency after 1 (one) years from the date of completion of the work.

- B) The responsibility of future maintenance will have to be done by the successful bidder for 1 (One) year.
- C) The L1 bidder will have to do all the required foundation works before installation and also the required Electrification works as per his necessities.

Work order shall be issued by the Chairman, Uttarpara-Kotrung Municipality & the payment will be made by the Chairman, Uttarpara-Kotrung.

- D) If the agency fails to do the work as per the agreement with the Department, penal action in the form of forfeiture of earnest money and or security deposit money, as decided by the authority, will be imposed on the agency and the decision of the authority will be conclusive and binding. The tender accepting authority of **Uttarpara-Kotrung Municipality** reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.
- 12) **Refund of EMD:** The Earnest Money of all the unsuccessful bidders will be refunded through online process after uploading Financial Evaluation as per Government Order.
- 13) Prospective applicants are advised to note carefully the **minimum qualification criteria** as mentioned in '**Instructions to Bidders**' stated in Section 'A' before tendering the bids

- 14) Conditional / Incomplete tender will not be accepted under any circumstances.
- 15) The intending Tenderers are required to quote the rate online.

Details are available at the Web Site stated in Clause A.1. above. DSC is given as a USB e-Token.

iii. The contractor can search & download N.I.Q. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause A.1 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

#### iv. Participation in more than one work:

A prospective bidder shall be allowed to participate in the job either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single job all his applications will be rejected for that job.

#### v. Submission of Tenders:

Tenders are to be submitted through online to the website stated in Clause A.1. in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC).
